1. The sealed tenders will be sent in the name of the Director, BSF Academy, Tekanpur, Gwalior (MP)- 475005.
2. Sealed tenders will be submitted in the enclosed performa duly filled. Tenders will not be accepted on plain paper.
3. Word "TENDER FOR SUPPLY OF IMFL" will be written on the top of the Tender Envelope.
4. Tenders will be submitted through Registered post or to be placed by hand duly sealed in a sealed tender box to reach by 1200hrs on 31st July 2018. Samples will be deposited by hand.
5. No tender will be accepted after 1200hrs on 31st July 2018.
6. Tenders will be opened by a board of officers on 31st July 2018 at 1600hrs in the presence of intending tenderers/their authorized representatives.
7. Director, BSF Academy, Tekanpur reserves the right to reject any or all tenders without assigning any reason. In case of any dispute, the decision of Director, BSF Academy, Tekanpur will be final.
8. An amount of Rs 1,00,000/- (one lac only) will be deposited as an earnest money in the case of Liquor in the shape of Bank Draft in favour of Liquor Fund BSF Academy, payable at SBI BSF Tekanpur (Code No-8284). In case the tender is rejected, the earnest money will be refunded immediately. The earnest money of successful tender will be retained till the end of tender period.
9. The contract for the supply of liquor will be for the period from 01<sup>st</sup> Aug 2018 to 31<sup>st</sup> Mar 2019 and it can be terminated before expiry of the contact period in the case of supply of liquor is not found as per sample and desired quality.
10. Incomplete and conditional tenders will be summarily rejected.

11. The F.O.R. will be at BSF Academy, Tekanpur, Gwalior (MP).
12. Four bottles of each brand duly sealed will be produced as sample on the day of opening of tender.
13. The Director, BSF Academy, Tekanpur reserves full rights to place orders on any quantity of approved brands of IMFL.
14. In case of damages/deficiency of stores found at the time of receipt, the cost of damaged/deficient stores will be fully borne by the contractors/suppliers inclusive of CST/VAT.
15. If any other charges quoted extra (ie. VAT, CST) are applied, the same must be specifically stated. In the absence of such stipulation in the tender, it will be presumed that the prices include all such charges and no claim for the same will be entertained. It is the duty of consignor to arrange unloading of stores at the destination.
16. The tender documents are not transferable, direct or indirect conversing on the part of tendered or their representative will disqualify the tender.
17. 100% inspection of stores supplied by the tenderer will be carried out by a survey committee in the premises of BSF Academy. In case of disqualification, stores will be lifted by the tenderer at own arrangement within 10 days.
