GENERAL TERMS AND CONDITIONS OF TENDER & CONTRACT

NB: These conditions should be read very carefully by the tenderers while filling in their tenders.

1. Sealed limited tender from manufacturers, distributors, Authorized dealers accompanied with the earnest money in the shape of BD/FDR for Rs.50,000/- drawn on SBI Code No. 8284 in favour of IG STC NON CPC FUND, Tekanpur, Distt- Gwalior (MP) so as to reach this office on or before ...23/04/.2018 at 1530 hrs for supply of Canteen Misc-Items as per specification attached to this limited tender form.
2. The rate unit must not be altered under any circumstances and it should be entered in figures as well as in words.
3. Limited tenders will be opened on ...23/04/2018 at 1630 hrs (Technical bid) by a board of officers and financial bid will be opened after finalization of technical bid. Tenderers or their authorized representatives may be present at the time of opening of limited tenders.
4. Further negotiations with only those firms will be done who qualify in technical & financial bids.
5. Supply will have to be completed within 20 days from the date of placement of supply order failing which supply order & contract will be cancelled & performance money deposited will be forfeited.
6. The earnest money will be refunded to those firms whose tenders will not be accepted.
7. Permanent Income Tax/ GSTN Number will have to be furnished along with the tender.
8. The approved supplier/ contractor shall be deemed to have carefully examined the conditions specifications, sizes, make and drawings etc of the goods to be supplied. If he shall have any doubts as to the meaning of any portions of these conditions or of the specifications drawings, he shall before submitting his tender/ quotations refer to the IG, STC BSF Tekanpur, Gwalior (MP) his representation and get clarifications.
9. The tenderer shall not assign or subject this contract in full or part thereof to any other agency.
10. Canteen Misc- Items shall be of the best quality to the specifications, trade mark laid down for them and strictly in accordance with the approved standard sample. In case any of the articles supplied not being of approved specifications & mismatch with sample, same shall be liable to be rejected or replaced and any loss caused as a result of rejection or replacement of supply shall be entirely at the account of the tenderer.
11. The IG STC BSF Tekanpur or his duly authorized representative shall have at all reasonable time access to the supplier's premises and shall have the power at all reasonable time to inspect and examine the materials and workshop of goods.
12. In case the canteen items other than the approved quality make or size are supplied, they shall be rejected and will have to be replaced within the period prescribed for the completion to exigencies of public work interest. In case such replacement is not possible, the price of such articles will be reduced suitably. The price fixed by the The IG STC BSF Tekanpur will be final.
13. The tenderer shall be responsible for the proper packing so as to avoid damage under normal conditions of transport by sea, rail and road or air and delivery of the materials in good condition to the consignee at destination. In the event of any loss, damage, breakage or leakage or any other shortage the tenderer shall be liable to make good such material. No extra cost on such account shall be admissible.

14. All rates quoted in the tender will be for supplies at STC BSF Tekanpur. Any decrease in taxes announced after the said date, the successful tenderer shall have to reduce his rates accordingly. No charges for transportation will be paid by the STC BSF Tekanpur and the delivery of the goods shall have to be made at STC BSF Tekanpur distt- Gwalior (MP) (30 km from Gwalior railway station on Gwalior-Jhansi road).
15. The tenderer whose tender is accepted shall arrange supplies within the period specified for the item as per the specific terms and conditions of supplies. The date of placing the supply order will be date of commencement for supply within prescribed time limit.
16. The contract of supply can be terminated at any time if the supplies are not made to the satisfaction of the The IG STC BSF Tekanpur (Gwalior, MP).
17. Tender should be filled in ink/ball point. No tender filled in by pencil or otherwise shall be considered. No overwriting should be done. Correction, if any should be done clearly and initialled.
18. The tenderers should endorse signature on the tender form & general terms and conditions.
19. Rates will remain valid up to minimum one year from the date of issue of tender.
20. Each tender must be accompanied with earnest money in the shape of BD/FDR for Rs.50,000/- drawn on SBI code no. 8284 in favour of IG STC NON CPC FUND, Tekanpur, distt- Gwalior (MP). No adjustment of the bid security amount out of pending bill amount with the department will be allowed. The tenders received without bid security amount or with less bid security prescribed will not be considered. The bid security will remain deposited in the office of the The DIG STC BSF Tekanpur. After the final decision on the tenders, the bid security of unsuccessful tenderer will be refunded and that of successful tenderer will be liable to be forfeited at the decision of the The IG STC BSF Tekanpur in the case of successful tenderers refusing to accept the order placed with him on account of market fluctuations or for any other reasons.
21. The insurance charges will have to be borne by the suppliers and STC BSF Tekanpur shall not be required to pay such charges if incurred.
22. No advance payment will be made. The payment shall be due and payable by the IG, STC BSF Tekanpur only when the quantity delivered has been inspected and accepted by the stores inspection committee appointed by the STC BSF Tekanpur and certificates of having done is recorded by the committee. In case of disputed item 10% to 15% of the amount will be withheld and will be paid on settlement of the dispute.
23. The validity period for the said store is up to one year from the date of issue of tender and the delivery period is fixed within the month from the receipt of supply order. However these can be extended by the IG, STC BSF Tekanpur on receipt of the written request of the contractor/supplier if the IG, STC BSF after considering the particular circumstances of the case considers the same fit for granting such extension.
24. But granting such extension will always be subject to the conditions that the taxes, if any increased during the extension date/period will not be borne by the Deptt. However on any reduction in taxes, during the extended period the supplier/contractor shall have to reduce the taxes accordingly.
25. All legal proceedings if necessary arise to be instituted by any of the parties (Govt contractor) shall have to be lodged in Court situated in Gwalior and not elsewhere.
26. The tenderer shall give the address on which notice, information or communication required to be given to him are to be sent. Changes in the address of the party would be intimated to the IG, STC BSF Tekanpur invariably and this change of the address of the firm will be considered valid from the date of receipt of such intimation in the office of the IG, STC, BSF Tekanpur, Distt- Gwalior (MP).
27. While making comparison of rates quoted by the tenderers, local tenderers will be given preference if rates and quality of store are equal.

28. The inconvenience caused to the Deptt on account of delay made in the supplies by the tenderers/contractors shall be deemed to have caused losses to the department. The loss will be ascertained by the IG, STC, BSF Tekanpur and the tenderer/ contractor will be liable to make good such losses. Even such monetary losses will not be borne by Deptt.
29. Tender forms received without signatures of the tenderer/ contractors or his duly authorized agent or received incomplete and not filled in accordance to the prescribed terms and conditions will also liable to be rejected.
30. The person signing the tender form shall be deemed to warranty that he has authority to do so. Therefore, all such tender forms which are signed by someone or another person on some concern's/ firms behalf should invariably be accompanied by duly executed and certified power of authority. It shall be lawful for the IG, STC BSF Tekanpur to reject outright, at his own discretion, if such tender forms are not accompanied by a duly verified power of attorney.
31. There should be mentioned period of a after sale service/ warranty in the quotation, the minimum period should be one year.
32. No other conditions except those as laid down above will be entertained. Tenders with any other condition etc may be out rightly rejected.
33. Following is the list of documents to be attached with the bid form :-

 - (iv) EMD
 - (v) Last 3 years IT return certificates
34. The IG, STC BSF Tekanpur reserves all rights to accept or reject any tender without assigning any reason thereof or concludes a parallel contract with another firm for the same stores and at his own discretion may also drop any time without assigning any reasons thereof.
